- C. Supervisor McConnell informed the board that the water system located in the library is in need of repair/replacement. That it has once again failed the Department of Health test requirements. He has been in contact with Scott Shute at Shute's water who provided 2 options to take care of this. His recommendation would be the UV light water system which would eliminate the need for someone to regulate the bleach, etc.... this would cost \$9,400. Supervisor confirmed with Attorney Jeff Brown that we could consider this an "emergency expenditure" under our procurement policy as it effects the drinking water within the Town Hall. Councilor Dwyer questioned other drinking water options. Town Clerk Colburn advised that there is a water cooler and we have signage advising people not to drink the water but people don't read signs and that the bigger concern is the drinking fountain in the library. Jessica Rice, the library director also stated that they also have a water cooler for employees but the fountain is a concern even with signage.

Starting in January we will have 2 Full time ALS providers and 2 full time BLS providers with benefits working on rotating schedules. This will provide almost all the hours required in our contract for 2024. The remainder of the hours each week will then be picked up by our part-time staff.

- B. Committee Reports
- 1. Community Center Development
  - a. Crossroads Project. Information Officer Sue Marzo reported to date we have received 439 survey responses and reiterated that residents have until December 22<sup>nd</sup> to send in their surveys
- 2. Jeff Palin advised of upcoming project at the current Community Center advising that the next project should be the porch. This project will include:
  - Removal& disposal of porch ceiling, railing, flooring, and columns.
  - Inspect floor join and advise the Town of the findings.
  - Install new PT 2x8 floor joints, and connecting to the existing framing
  - Install PVC celling, flooring, railings, and stairs consistent with manufacturers recommendations.
  - Support all columns, and remove existing column base.
  - Install 4 new fiber glass columns and bases
  - All with 16 calendar days of project start date.

They have obtained 3 quotes from Lucas Amidon, Tom Murfitt and HK Contracting. Lucas Amidon came in the lowest at \$19, 500 to start in the spring.
